The health and wellbeing of our passengers, crew and staff remain our highest priority.

Swiss Flight Services (SFS) would like to reassure our guests that we continue to closely monitor developments concerning the COVID-19 situation.

In line with current recommendations issued by Switzerland, many European countries as well as aviation authorities, we bring to the attention of our passengers, the following for their safety and comfort:

- Before making any travel plans, consult national authority and embassy websites of your destination country, checking their latest entry requirements and information.
Entry rules vary from country to country and failure to comply with local requirements may result in your entry being denied. In such a case, SFS cannot be held responsible for your repatriation.
- You may be required to complete additional documentation on arrival in your destination country.
- You may have your temperature taken at your airport of departure or arrival.
- Data protection – Any personal data submitted will be securely stored by SFS in accordance with Data Protection laws for the requisite period. This information shall be available for authority inspection if requested.
- We require all passengers to wear a medical face mask at all times in the airport and on board. SFS provides Hydroalcoholic hand sanitizing liquid for hand disinfection as well as medical face masks for passenger use in flight.
- All passengers are required to complete this form as well as answer the questions below.
- In the event of a YES answer to any questions the passenger concerned will be contacted directly by an SFS representative.
